# NEW CALIFORNIA LAWS FOR 2020

During my annual research of new laws that were passed by the California State Legislature, which went into effect on January 1, 2020 (unless noted), I found that the state law makers have lived up to their past proliferation. As in the past, there were over 1,000 new laws passed in 2019.

This year's laws range from necessary to bizarre, and I will try to highlight as many as space allows. I have included the legislative bill's number in case you would like to read more about a particular law.

I will begin by trying to answer a question many people are asking: Do I need a California Real ID in 2020? The answer is - maybe.

Starting on October 1, 2020, the U.S. Department of Homeland Security will require certain types of identification to travel aboard an aircraft within the United States. If you do not have a valid passport, a military ID, or a Global Entry Card, you will need to get a REAL ID from the California DMV to be able to board an airplane after October.

What is the difference between a regular driver's license and a REAL ID? Since California DMV will now issue an ID card or driver's license to undocumented immigrants, those forms of identification are not valid for flying within the U.S.

The REAL ID requires multiple forms of identification to qualify and include proof of identity (valid passport or birth certificate), proof of social security number (SS card or employment record with SS number displayed), and two proofs of California residency (utility bill, bank statement, or similar document showing your current address).

To determine if you currently have a REAL ID, the license or ID

card must have an image of a white star on a golden bear in the upper right hand corner. Other states will have different images, but they all must show the white star. If your CDL or ID card does not have this symbol, there will be a notation in this spot which says "Federal Limits Apply" or "Not For Federal Purposes".

## TRAFFIC LAWS:

(AB 317) Makes it unlawful for any person to sell, or offer for sale, an appointment with the DMV.

(SB 485) Eliminates the court's authority to suspend or revoke a person's driver's license who has been convicted of a non-driving offense, i.e., prostitution, vandalism, petty theft, etc.

(AB 1810) You are no longer required to have a motorcycle endorsement to operate an electric scooter.

(AB 47) A point will now be added to your driving history for a distracted driving violation beginning in July 2021. Three points could result in a suspension of your license for six months and higher insurance costs. The points will stay on your driving record for three years.

## Now for a couple of the most unusual, and even bizarre, laws passed last year –

(SB 395) Allows a person to obtain a special permit to collect and eat road kill (It's true – look it up). It even had the support of PETA.

(SB188) This law bans discrimination in the workplace based on a person's hair style.

(AB46) This legislation will replace certain derogatory words that include, but are not limited to, "mental illness" and "mental defective". More culturally sensitive words such as "mental health disorder" will now be used.

(SB72) This law will allow voters to register to vote on Election Day in March and November. You can now register to vote and cast your ballot on the same day and at the same location.

(AB1707) Smart phones with cameras can now be taken into and used in the polling place and voting booth. However, a person may not record or photograph a voter entering or exiting a polling place with the intent of dissuading another person from voting.

(SB310) Now convicted felons who have completed their parole or probation are allowed to serve on juries. The law does exempt registered sex offenders.

(AB32) By 2028, all private prisons must be phased out in California. The private prison industry has already filed a lawsuit to overturn this legislation.

(SB313) All animals are banned from performing in circuses, except dogs, cats and horses. Rodeos are exempt from this law. This law also bans ICE detention centers which means the law will most likely be challenged by the federal government.

(SB419) This law now prohibits schools from suspending students in grades 4-8 for disruptive behavior or defying teachers and administrators.

(AB51) This law will prevent anyone from requiring employees or applicants to sign a mandatory arbitration agreement as a condition of employment. It also prevents a company from offering an opt-out option. This law will likely be overturned since it is in conflict with the Federal Arbitration Act, and the states of Kentucky and West Virginia have already had similar laws overturned in Federal court.

(AB5) Employers will be limited in their ability to classify certain “gig” workers as independent contractors. The gig economy is a description of those working with short term contracts or people who do freelance work. This law would most greatly affect people driving for Uber and Lyft. It was sought by the drivers, but is opposed by the companies who have already filed legal action to overturn the law.

(AB276) This bill will restrict the number of vaccine exemptions a doctor can issue. The issuance of five or more exemptions will result in a state review, and possible sanctions. The law

will prevent doctors from selling vaccine exemptions.

(SB30) This bill would remove the requirement that persons be of the same sex, or of the opposite sex and over 62 years of age, in order to enter into a domestic partnership. Now anyone can file to be domestic partners.

(AB1482) The legislation will limit the amount that rents can increase annually (rent control) to 5%, plus the cost of living.

(SB8) This law will ban smoking in all state parks and at all state beaches.

(SB61) As of January 1st, Californians will have to wait 30 days between purchases of semi-automatic rifles.

(AB375), The California Consumer Privacy Act – This law is said to be the toughest data privacy Act in the U.S. It is also why you are seeing a plethora of announcements about new terms of service and updated privacy policies showing up in your email. It is hoped that this Act will become the standard for the entire country.

While many seem to think this bill protects their information from being sold to advertisers, it does not. This bill only covers information which might be lost due to a data breach. The catch is that it is illegal now for companies sell your data if you tell them not to, but if they do anyway, you can't sue them.

Although many large companies, including Microsoft and Twitter, seem to be going along and complying with the law, many others like Google and Facebook have said they will not comply with the law. Both continue to play the waiting game, and seem to be betting the state is not prepared to do any type of investigation into complaints about their privacy actions. In 2018 Facebook made \$55 million providing advertisers access to their user's information, and government fines are unlikely to even come close to that figure.

Because other states are beginning to follow California's lead and are forming their own privacy laws, there is speculation that there will be a lot of pressure on Congress to pass federal legislation regarding individual privacy.

## CONTRA COSTA COUNTY EMPLOYEES RETIREMENT ASSOCIATION UPDATE

### *Greetings and Happy New Year!*

I hope you had a wonderful holiday season and were able to spend quality time with your loved ones, friends and colleagues.

This is the time of year when we get anxious to find out what the Cost of Living Adjustment (COLA) will be. The Bureau of Labor Statistics Consumer Price Index (CPI) for 2019 was published on January 14, 2020. As you might know our COLA is based on the CPI for the San Francisco-Oakland-Hayward Area. The increase in the CPI from January 2019 to December 2019 was 2.5%, which was confirmed by our actuary, Segal Actuarial Services.

On January 22, 2020, the Retirement Board voted to approve the COLA increase effective April 1, 2020. This means you will see the COLA increase on your May 1, 2020 retirement check.

If you were retired on or before 03/31/2019, and in Tier 1, Tier 3 (Service Retirement), Tier 4 (3% COLA), Safety Tier A and Safety Tier D you will receive your maximum 3% COLA because a 1/2% will be carried over from your COLA bank. If you were retired on or before March 31, 2019, and you are in Tier 2, Tier 3 (Disability Only), and Tier 5 (3%/4% COLA and Disability Retirement Only) your COLA will be 3%, due to your COLA bank only having 1/2% to carry over. If you were retired on or before March 31, 2019 and you are in Tier 4 (2% COLA), Tier 5 (2% COLA), Safety Tier C and Safety Tier E you will receive your maximum 2% COLA, with 1/2% carried over to your COLA bank.

Here is an example on how the COLA bank works. If your retirement group has been granted a maximum COLA of 3%, and the CPI for the year is 4%, 1% will go to your COLA bank. If the next year the CPI only reaches 2% and your maximum COLA is 3%, you will still get your maximum 3% COLA because 1% that you have in your COLA bank from the previous year will be carried over. If you do not have anything in your COLA bank, and the CPI is 2% you only receive 2% because there is nothing in your COLA bank to carry over. Any COLA must first be approved by Retirement Board before it can be applied.

I hope the above information helps you understand how the COLA is calculated and how it is applied.

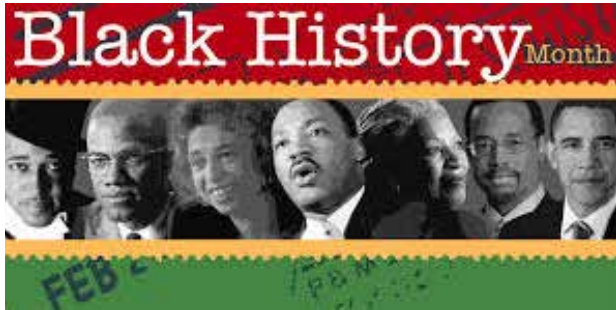

# 2020 CCCREA SCHOLARSHIP RULES AND REQUIREMENTS

The CCCREA Mary Lou Williams Scholarship Fund has been developed to promote, support and assist in the higher education of its members and their families.

**AWARDS:** At least four scholarships of \$1,500 each will be awarded annually in June of each year and available to the applicant for the fall school semester.

**ELIGIBLE APPLICANTS:** The scholarships are available to all CCCREA members in good standing, as well as their children, stepchildren, grandchildren, step grandchildren, nieces, and nephews (including grand-nieces and grand-nephews).

**REQUIREMENTS:** Applicant must be either a high school senior with a grade point average (GPA) of 2.5 or higher, and has applied to, or been accepted by, a college, university, or trade school with a minimum two year course of study, OR a student with a GPA of 2.5 or higher who is already attending an accredited educational institution.

Completed applications must include **official transcripts**, one letter of recommendation, and a brief essay addressing the student's academic accomplishments, extra-curricular activities, and description of any community service. Applications must be post marked no later than March 31 of the year of application.

For a transcript of grades to be considered official, it must be mailed directly from the institution and sealed upon delivery with the application.

**FINAL SELECTION:** Applications will be screened and ranked by an outside independent rater. Based on these recommendations to the Scholarship Committee, the Board of Directors will determine the award recipients prior to the beginning of the fall semester. Scholarship winners and their sponsors will be invited to the fall luncheon to receive their award.

Please note that if any of the above requirements are not met, or included with the application, the application will be deemed incomplete and not considered for an award.
